Chronic diseases and healthy ageing: Experts are joining forces today in Madrid

(Madrid, 24th October 2014)

Today, the first Stakeholder Forum of the Joint Action CHRODIS (JA-CHRODIS) (see notes to editors 1 & 2) is being held in the Institute of Health Carlos III in Madrid (Spain). Participants will learn about the initiative and be able to contribute to its activities by advising on the needs of users, regulators and the private sector in relation to diabetes, cardiovascular diseases, and multimorbidity. The Forum will facilitate the exchange of information and experience between those implementing the Joint Action and its stakeholders, such as policymakers, managers and patients' representatives from across Europe.

Juan Riese, coordinator of JA-CHRODIS, says "the Forum provides an excellent opportunity to engage the wider public in our work and to build an external cooperation network. This is a first step towards making a real impact with our work on the ground."

Coinciding with the Stakeholder Forum, JA-CHRODIS is presenting its website (<u>www.chrodis.eu</u>) where interested parties can not only find up-to-date information on JA-CHRODIS but also relevant news on the latest European developments in the areas of chronic diseases and healthy ageing. In addition, the website is the go-to-place for all stakeholders to download and view all documentation and outputs of the Joint Action.

In Europe today, 4 out of 5 people over 65 suffer from at least one chronic disease like diabetes or cardiovascular disease. 65% of this age group suffers from multimorbidity, i.e. two or more chronic diseases. This number rises to 85% for the 85-year-old group.¹ The treatment of chronic diseases demands 70-80% of healthcare budgets.

The European Commission, specifically through its flagship initiative European Innovation Partnership on Active and Healthy Ageing, aims to improve the healthy lifespan of European citizens by two years by 2020. JA-CHRODIS is designed to contribute to this goal.

Notes to editors:

(1) As a European collaboration (2014-2017), JA-CHRODIS brings together over 60 associated and collaborating partners from e.g. national and regional departments of health and research institutions, from 25 Member States. These partners work together to identify, validate, exchange and disseminate good practices on chronic diseases and healthy ageing across Europe and to facilitate their uptake across borders. The focus is health promotion and primary

prevention as well as the management of diabetes and multimorbid chronic conditions.

One of the key outcomes of the Joint Action is the Platform for Knowledge Exchange, which will include both an online help-desk for policy makers and a clearinghouse providing collection of leading-edge best practices and scientific knowledge on chronic care.

(2) Joint Actions are one funding instrument under the third EU Health Programme 2014-2020. They have a clear EU added value and are co-financed either by competent authorities that are responsible for health in the Member States or in the third countries participating in the Programme, or by public sector bodies and non-governmental bodies mandated by those competent authorities. Joint Actions provide a genuine European dimension in order to make sense both technically and in terms of policy. Depending on the scope of the action Joint Actions involve on average 25 partners.
