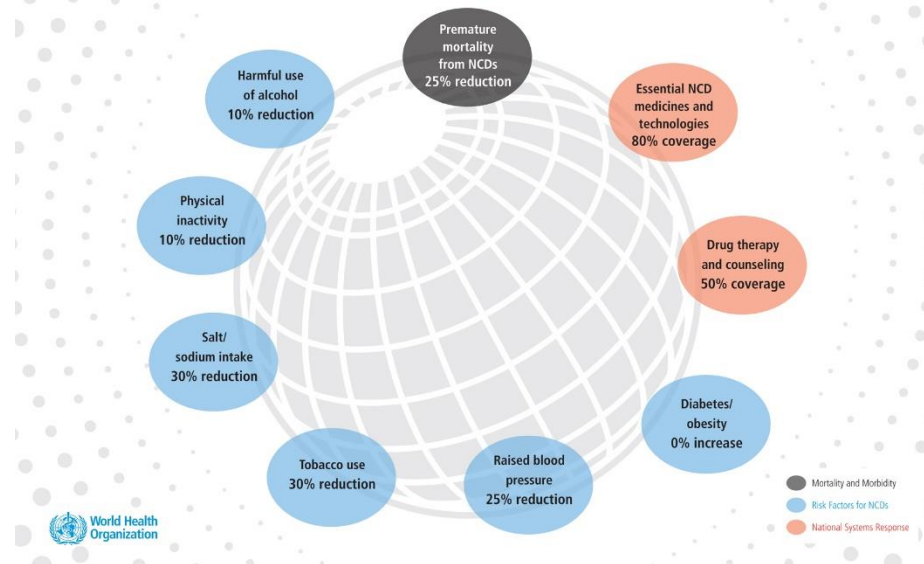

Support the Commission in monitoring the progress towards reaching the Sustainable Development Goal 3



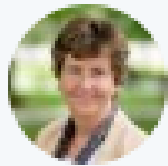
Coordinate

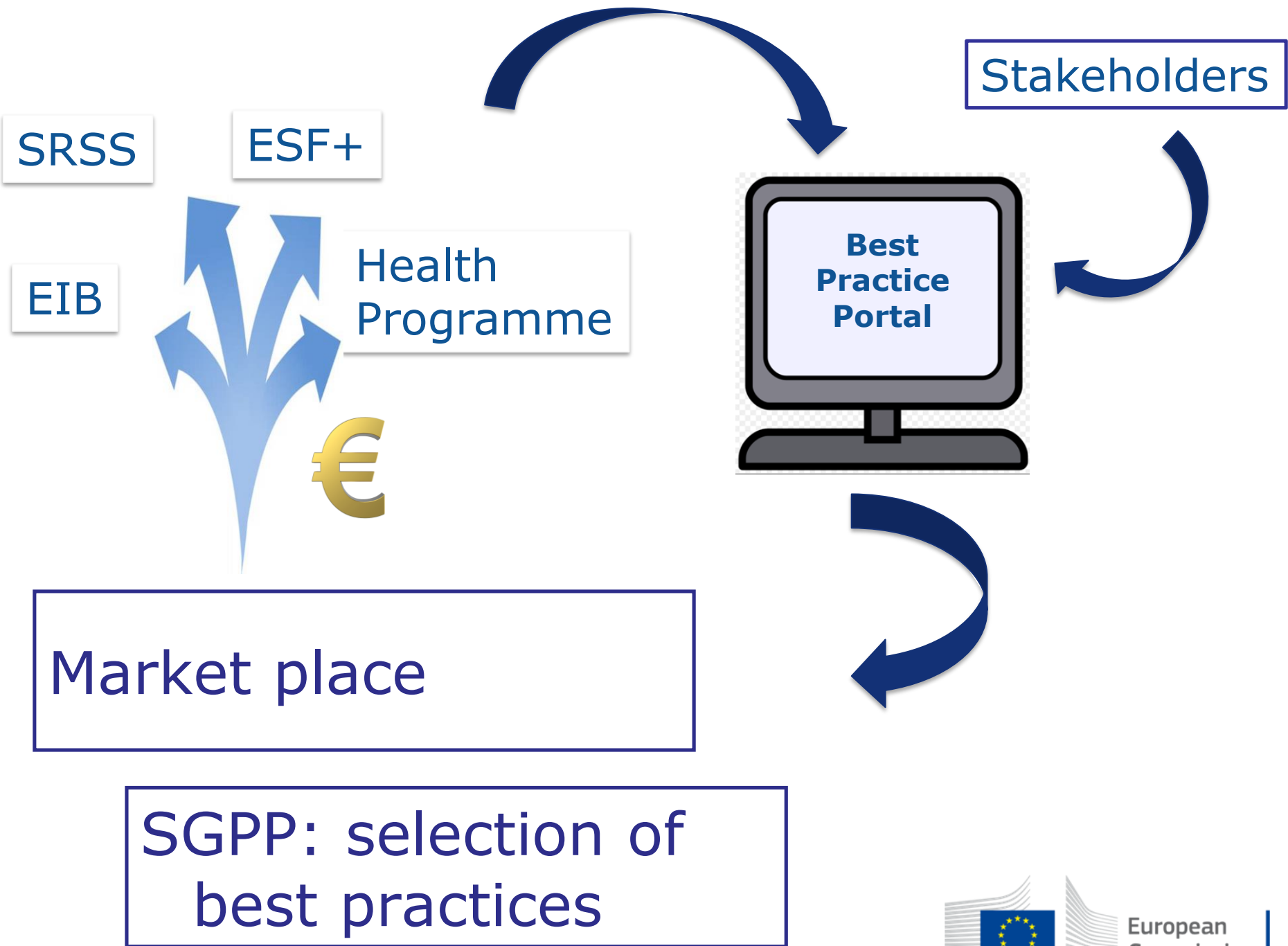

EDUCATION TRAINING

- Quality of education and training systems

- Lifelong learning, notably upskilling and reskilling taking into account digital skills, better anticipating change and new skills requirements

SOCIAL INCLUSION

- Active inclusion
- Integration of third country nationals and marginalised communities e.g. Roma

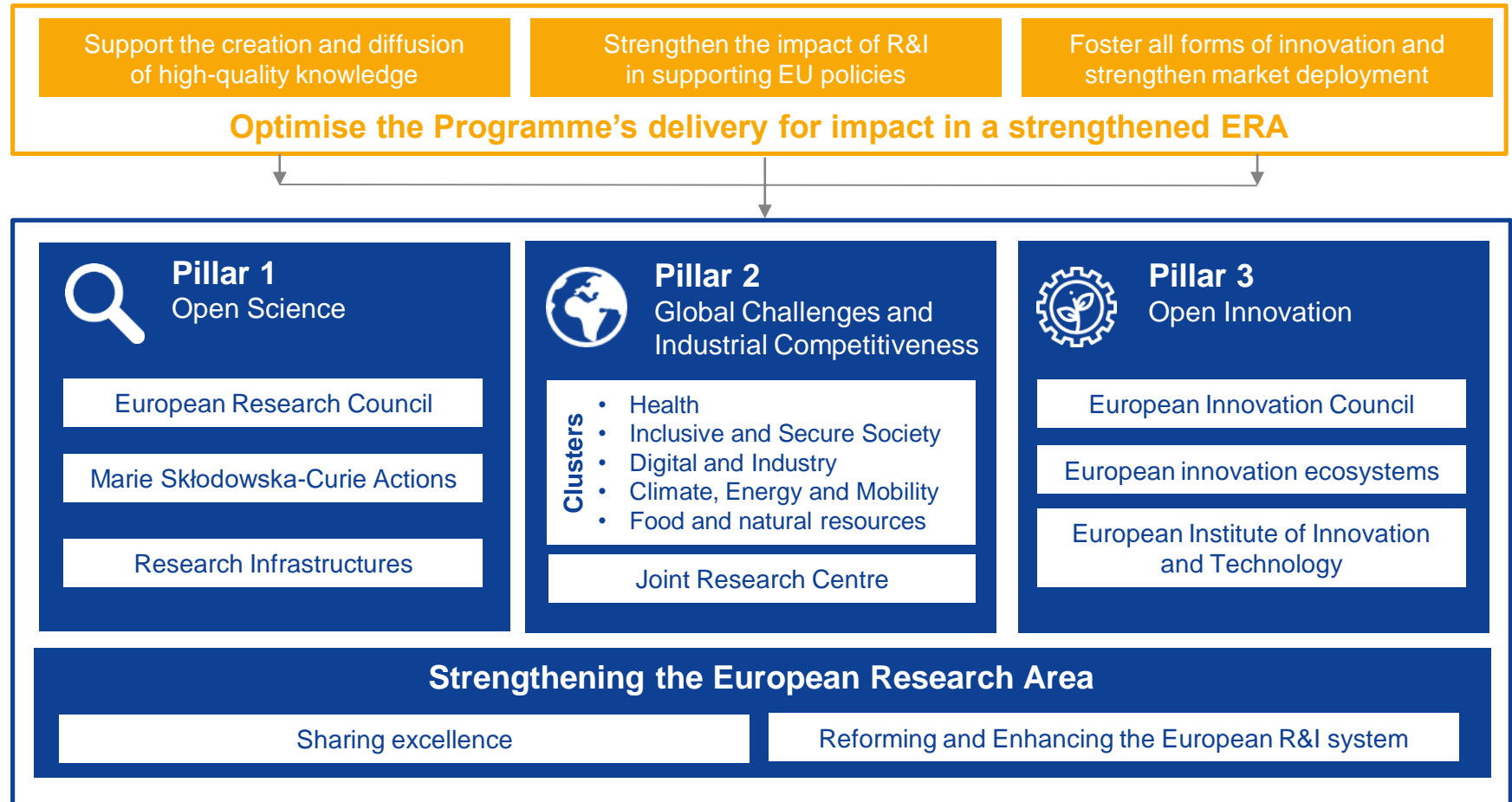

#3 Non-Communicable and Rare Diseases

Non-communicable diseases remain a major health and societal challenge requiring personalized approaches.

- Earlier and more accurate diagnoses
- Prevention and screening programmes
- Treatments and cures
- Palliative care
- Comparative effectiveness of interventions
- Scale up of health interventions

Structural Reform Support Service (SRSS)

Commission service with a mandate to:

- Support member states with the preparation, design, and implementation of growth-enhancing reforms
- Provide tailor-made support on the ground
- Steer and coordinate technical support provided by the Commission

Participation by Member States is voluntary

Reform Delivery Tool

- **Financial support** available to all Member States
- **European Semester** reform challenges

Technical support

- Tailored **technical expertise** available to all Member States
- Continuation of the **SRSP**
- **Wider scope** for intervention

Convergence Facility

- **Financial and technical support** to Member States committed to adopt the euro
- Reforms to prepare for **participation in the euro area**
